ALERT / ESCALATE	<ul> <li>The Month 4 Finance Update was received and the Committee noted that at Month 4 the forecast recurrent deficit had been increased to £39.3m to reflect the £7.9m forecast shortfall in savings delivery against the £16.1m recurrent savings target. The Committee noted that Actual expenditure to M4 on delegated budgets was showing a £5.2m overspend and this was offset by a</li> </ul>
	£5.3m underspend on Non Delegated budgets to give a small underspend of £0.1m. A significant amount of Reserve budgets had been phased into the M4 position to cover estimated costs already included in the delegated position but where funding has not yet been released into delegated budgets.
ADVISE	<ul> <li>The Committee received a presentation on the current position in relation to the Integrated Medium Term Annual Plan (IMTP) 2021-22 and the feedback received from Welsh Government. The Committee agreed to be kept updated in terms of governance and assurance on the concerns raised by Welsh Government and the actions being undertaken to address this.</li> <li>The Committee discussed the Committee Effectiveness Annual Self-Assessment and agreed that this would be deferred to the October 2021 meeting in order for Members to complete the survey.</li> </ul>
